The first stage of the process is the PRE ITA (Pre Invitation to Apply) stage, at this stage, you are required to evaluate your qualifications with the evaluation body that relates with your qualification while preparing for the IELTS test in order to gain access to the pool where the most qualified candidates are selected and sent an invitation to apply for Express Entry. After fulfilling the above requirements, you would be added into the pool.

Here are some things you need to know to get started on your application

- If you are a master's degree holder, under 35yrs with at least three years verifiable work experience, then this is absolutely for you. Canada believes you are an individual with skilled work experience, and you are the reason for this immigration problem.
- Where you are over 32 years old, married or not married, and with no master's degree or any professional diploma, you are advised to consult our counsellors to assess your eligibility, and work with you through possible eligibility, as you are not eligible for this program with a first degree only.
- It takes an average of 9 months to process, it may be longer depending on the turnaround time of each stage and that of third-party resource (i.e IRCC, ECA). All other things being equal, it should not be more than 9 months.
- You will have to take the IELTS exam to assess your English speaking, writing, listening and reading skills, this is to ensure that language barrier would not be an issue while trying to settle in Canada
- If you are a first-degree holder, but with a professional diploma that is equal to a 12 - 18 month diploma, and less than 34 years, then you are eligible
- Unlike other visas that you may be used to where consulates will be more interested in your tie to your home country. Canada wants to see that you have no ties with your country. If you are married you are advised to apply with your spouse and kids. If you are not married, you are fine there is no special advantage for the married.
- It's a point-based system where many factors determine your eligibility and your eventual success at the end of the process, you get an equal chance as any other person as long as you score the required points to get selected and subsequently get your visa approved
- This process is for those who have been cleared by the police for not having any criminal records 10 years prior to the application in any part of the world. Those who have adverse immigration records i.e overstaying in any country or being deported from any country are also advised to not apply.
